# REQUIREMENTS OF ABSTRACT SUBMISSION

Before the registration deadline for participation in the conference, you must upload the presentation abstract, prepared in accordance with the established requirements, as an attached file using your registration details. The abstract file must be uploaded in MS Word format (".doc" or ".docx"). Requirements and design of template for abstracts can be downloaded from the conference website. The abstract is two pages. Please note that the maximum number of authors of one report - no more than three. One scientist cannot be the author (co-author) of more than two theses. For necessity, the information provided by you, can be edited.

Title should be short and reveal the main essence of the research which will be presented in the report.

The organizing committee reserves the right to reject a conference participation application due to failure to comply with the registration procedure, inconsistency of the presentation topic with the conference areas, lack of novelty, or detection of plagiarism.
